**Acute toxicity** This product is expected to be of low acute toxicity. Under normal conditions of use, adverse health effects are not anticipated.

**12.1 Toxicity**

Aquatic toxicity tests have been conducted as per ASTM D5560 test method (Microtox). The product alone has been shown to have low ecotoxicity. As it is an absorbent used for cleaning up oil spills, it has also been shown that the product lowers the ecotoxicity of the oil through absorption and encapsulation.

**12.2 Persistence and degradability**

Product is 100% biodegradable in 1-5 months under aerobic conditions.

**12.3 Bioaccumulative potential**

The product does not bioaccumulate.

**12.4 Mobility in soil**

Product itself is not mobile in soil and does not release any adverse leachate. TCLP and GC analysis conducted on the product + sump oil (1:1 w/w) also show minimal leaching of oil components (as total Naphthalene).

**12.5 Other adverse effects**

As the product is manufactured from by-products of cotton, it has been tested and found to not contain any pesticide residues.
